



MEMORANDUM OF AGREEMENT (MOA)

ON STUDENT EXCHANGE

BETWEEN

Naresuan University (NU)

Muang, Phitsanulok, Thailand

AND

Sias International University (SIAS)

Xinzheng City, Henan, China



Naresuan University (NU) and Sias International University (SIAS) agree to implement this memorandum of understanding signed on 2017/7/1.

This agreement is based on the principle of reciprocity and expresses the interest of both parties in exchanging students in the belief that the research and educational process at both institutions will be enhanced and that mutual understanding between their respective students will be increased by the establishment of such exchange programs.

1. The universities agree to encourage the development of the exchange program of students based on their respective academic and educational needs, for maximum of one academic year or two academic semester.
2. The parties recognize that the implementation of student exchange program will depend upon the academic interests and upon the availability of financial resources. Every semester, 5-10 students could be nominated to join in the student exchange program. For the students who are nominated by their universities, the application fee, tuition fee, and room fee will be waived by both universities for the students who are chosen for students exchange program, meanwhile, the food and international transportation shall be covered by students themselves.
3. This agreement is not intended to be a legally binding document. It meant to describe the nature and to suggest the guidelines of the cooperation described above. Nothing therefore shall diminish the full autonomy of either institution, nor will any constraints be imposed by either upon the other in carrying out the agreement.
4. The agreement shall become effective on the day representatives both universities affix their signatures and seals, will be in force for a period of 5 years, and is subject to revision or modification by mutual agreement. It is also understood that either institution may

terminate the agreement at any time, although it is assumed that such action would only be taken after mutual consultation in order to avoid any possible inconvenience to other institution.

5. For Mr. Chakrit Fuangprang and for Ms. Jinjin Chu shall serve as liaison officers for this agreement.
